We invite you to apply for **5 minutes slots to present your ideas** for implementing and communicating the Alpine Climate Target System. **Elevator Pitch Session live I on 13 May** focuses on pilot actions that support the **implementation of the Alpine Climate Target System**. **Elevator Pitch Session live II on 14 May** focuses on pilot actions with **special attention to communication** that support the implementation of the target system.

The presentations should be **without slides, just short oral short introductions** covering the **following issues**:

- Short presentation of pilot action: Which sectoral targets are supported by the pilot action and which timeframe is envisaged? How does the pilot action support the Alpine-wide implementation of the overall vision?
- Involvement: Which stakeholders are needed to further develop the pilot action?
- Wishes to the ACB: How can the ACB support the implementation of the proposed pilot action?

After the presentations, the panel of the introductory discussion shortly reflects on the ideas.
