## Executive Summary

Action Group 8 (AG8) aims at improving and enhancing policies and management strategies in the areas of climate change adaptation and risk management. The 2026-2028 Work Plan of AG8 is closely aligned with the strategic directions set out in the Action Plan, particularly those relating to Action 8. Building on the thematic priorities already defined, it ensures continuity with the work carried out in the previous Work Plan period 2023-2025.

Action Group 8 serves as a focal point for the exchange of knowledge and experience, enabling the development of common approaches to challenges in the field of climate change adaptation and risk management. Furthermore, a specific focus of the new Work Plan will be the leverage of the knowledge base, outputs and transnational Policy Recommendations developed within AG8 and through key projects such as X-Risk-CC, ADAPTNOW, Mosaic, and associated projects.

In addition, AG8 will collaborate with the Interreg Alpine Space Project BeCo – Beyond Conflicts on targeted approaches to prevent, manage, and resolve conflicts, fostering widely accepted and sustainable Nature-based Solutions (NbS) and climate change adaptation (CCA) measures, provided that the project receives funding.

## 1. Focus and Scope of the Action Group

Action Group 8 aims to further develop and implement risk management strategies related to natural hazards, while addressing emerging challenges posed by climate change and global warming.

The overarching goal is to foster sustainable, strategic, and climate-resilient development throughout the Alpine region through shared approaches – with the Action Group serving as a central hub for exchanging knowledge and experience.

## 2. Key Tangible Achievements 2023-2025

The key achievements during the last period 2023 – 2025 are:

- Policy level:
  - Policy recommendations on Enhancing vertical governance of CCA in the alpine space, through mandatory mainstreaming, multi-level coordination, and criteria- driven funding
  - Policy recommendations on Adapting to natural hazards in the Alps: Strengthening risk governance, risk culture, and climate-resilient land use
  - Expertise and policy Enquête on 3 July 2025, in Graz: 50 years hazard zone maps
  - Further development, enhancement and integration of the risk governance networks of the Alpine states (e.g. EUSALP, PLANALP/Alpine Convention and INTERPRAEVENT)
- Technical level:
  - Workshop on 13 June 2024 during the international conference [INTERPRAEVENT 2024](#) in Vienna: The role of Nature-based Solutions
  - Working paper on Nature-based Solutions – Implementation: Status, Challenges and Benefits
  - [Climate adaptation platform for the Alps \(CAPA\)](#): Roadmap for further deployment, user needs survey, further development and new entries
  - Joint Workshop of EUSALP AG8 and ADAPTNOW project on 7 November 2024, in Bolzano: Drivers and interests in developing CCA strategies and measures

  - Contribution to the initiative for the establishment of a transnational “peoples network” in risk governance (in cooperation with the international research society INTERPRAEVENT)

During the next period, AG8 will continue its work on the CAPA platform, the collaboration with ASP projects working on AG8-related topics, and involvement of the EUSALP Youth Council in the activities of AG8, as these actions have demonstrated clear added value and effectiveness during the previous workplan period.

### 3. Priorities 2026-2028

The 2026-2028 Work Plan of AG8 is closely aligned with the strategic directions set out in the Action Plan, based on the three main topics defined in the Action Plan:

- **Strengthening transnational cooperation in developing hazard and risk assessment methodologies and building on existing cooperation:** The Alpine Region is highly vulnerable to natural hazards such as avalanches, floods (including flash floods), heavy rainfall, and landslides, with growing concerns around permafrost instability and large-scale river basin floods. Climate change increases both frequency and severity of these events, making improvements in disaster risk reduction and policy preparedness crucial not only for mountain areas but also for lowland and cross-border regions. Effective adaptation requires coordinated action and the development of risk assessment methods aligned with EU frameworks, particularly focusing on extreme, multi-hazard, and cascading events under climate change.
- **Pooling research activities on disaster risk management and climate change adaptation and mitigation across the Alpine region:** The impacts of climate change – linked to terrain instability, floods, glacier dynamics, and biodiversity loss – pose significant challenges for the Alpine Region. Numerous Alpine research institutions are studying these effects and exploring climate change adaptation and risk mitigation strategies. To maximize impact, coordinated research, knowledge exchange, and technology transfer are needed. Nature-based solutions, such as forests, wetlands, green corridors, and the wildland-urban interface, should be central to integrated climate and disaster risk management efforts.
- **Analysing the socio-economic consequences of climate-related natural disasters and establishing good risk governance:** Climate-related hazards threaten socio-economic development and settlement safety in the Alps. Expanding human settlements in hazard-prone areas, limited space, and more frequent extreme events heighten risks to people and infrastructure. Effective risk governance instruments and processes are essential to balance land use, raise awareness, address regional disparities, and manage conflicting interests in adaptation and mitigation. This includes enhancing societal resilience, local risk knowledge, and preparedness.

## 4. Communication

The AG8 and its members make use of a portfolio of communication tools and channels. The central platforms of communication are the EUSALP website and the CAPA portal, where the main outcomes of the AG and information are presented and shared. AG8 co-leader (EURAC) will supervise the communication of activities and actively participating in capacity-building and training initiatives organized by the EUSALP Secretariat on communication. In addition, the AG8 members use their institutional communication infrastructures, networks, and the networks of partner organisations to distribute information and results. Moreover, AG8 will be present at relevant national and international events, including EUSALP events, conferences, and workshops.

### 4.1. Dissemination and Communication Activities

<b>EUSALP website and social media channels</b>
A communication strategy will be framed with the new TSS communication officer and YC. Since AG8 has no social media accounts and no dedicated resources, news will be disseminated through EUSALP calendar, EUSALP website and social media accounts with the help of TSS and YC. AG8 will employ the CAPA portal as infrastructure for the provision and transfer of knowledge resources generated by associated projects and flagship initiatives.
<b>External dissemination (Interreg ASP and/or external communication channels)</b>
The AG8 members use their institutional communication infrastructures, networks, and the networks of partner organisations to distribute information and results. Moreover, AG8 will be present at relevant national and international events to present the work of AG8 and EUSALP.
<b>Dissemination of results to policymakers</b>
AG8 will organise a Conference in 2027 with the potential collaboration of other AG's and YC. Members of AG8 are expected to play a key role in disseminating results to relevant policymakers at various territorial levels. The group includes policymakers among its members, while others have strong institutional links with regional and local administrations. AG8 members will therefore contribute actively to ensuring that the results are communicated effectively to policymakers within their respective territories.

AG8 will provide text and graphics for the success stories and support TSS in their creation.

#### Organisation of Work

AG8 holds two meetings per year, usually one in person and one online, to discuss joint activities, align on content, organise activities, and update the Monitoring Matrix. The Co-Leaders of AG8 are responsible for the coordination and organisation of the structure and activities of the Action Group.

All AG8 members commit themselves to contribute to the activities of the Action Group. To fulfil the Work Plan, sub-groups (so called task forces) on specific topics may be established. Task forces consist of selected AG8 members who are responsible for the elaboration of this specific topic and presentation and discussion during an AG8 meeting with the entire group. Each task force has a lead. The task force lead is responsible for the coordination and progress of the specific topic. Any member can take over the role of a task force leader. At the elaboration of this Work Plan there is only one task force in place: the task force on CAPA.

### 6.2. Involvement of the Stakeholders

To support the work and improve the results, AG8 collaborates with different stakeholders, such as experts from other disciplines, if necessary, actors from national to local level and international networks. The goal is to work on horizontal integration of common topics and issues, to use synergies and expertise and to include other perspectives and inputs.

The following table gives an overview of the different stakeholders and the types of involvement.

Local, regional and national public stakeholders are institutions and authorities of the respective member countries that work in the field of risk management or climate change adaptation or are important for the implementation. They have different areas of expertise and responsibilities. Universities and research organisations include academic and non-academic scientific institutions present in the AG8 member countries as well as the International Research Society INTERPRAEVENT, which deals with topics closely linked to AG8. International organisations include the Alpine Convention, especially the Working Group on Natural Hazards (PLANALP) and the Alpine Climate Board (ACB), the European Topic Centre Climate Adaptation (EEA ETC/CA), the Interest Group Climate Change Adaptation of the Network of European Environmental Protection Agencies (EPA IG CCA), the OECD Task Force on Climate Change Adaptation (TFCCA), UNDRR Regional Office Europe and Central Asia. AG8 will engage with existing networks on disaster risk reduction and climate change adaptation such as the European Network We4DRR (women exchange for disaster risk reduction), national Platforms for Disaster Risk Reduction under the UNDRR, the Disaster Competence Network Austria (DCNA) and others, for the dissemination of results and AG8 activities and events.

### 6.3. The Role of the Youth Council

AG8 will invite interested representatives/members of the Youth Council to its meetings to present them the purpose and activities of AG8 and include them in AG8 activities.

The members of the YC will be actively involved in the definition of a communication strategy, and in the organisation of the 2027 AG8 Alpine Conference.
